#### I am genuinely proud to be Chief Executive of Austroads and to share our results for 2024–25 in our Annual Report.

#### The results in these pages speak for themselves:

- Continued strong research program and high report downloads, helping our members build, maintain and operate roads that improve economic efficiency and deliver greater benefits the community.
- Continued strong performance in telematics schemes, including record use of the National Telematics Framework, supporting improved freight productivity.
- Ongoing NEVDIS activity supporting vehicle registration and cross border transfers, with record transaction numbers.
- Strong growth in training for temporary traffic management and crash barrier installation, helping keep road workers and road users safe.

One of this year's key highlights was the 12<sup>th</sup> Austroads Bridge Conference, held in Brisbane in June 2025. With over 600 attendees and nearly 300 papers presented across five streams, it was our largest conference to date, furthering knowledge exchange within the bridge engineering community.

As the association of Australian and New Zealand roads and transport agencies, Austroads occupies a unique position within Australia's federation, playing a crucial role in delivering and implementing nationally agreed roads and transport priorities.

Austroads stands alongside only two other organisations of its kind: the Australasian Fire and Emergency Service Authorities Council (AFAC) and the Australia New Zealand Policing Advisory Agency (ANZPAA).

Like these federated agencies, Austroads aligns its priorities with input of its members. The Austroads Board collaborates collegially and confidentially to address common issues and leverage collective opportunities.

#### Our success reflects three key features:

- Our collaborative approach and strong partnerships with our members.
- A focus on complementing the work of our members, rather than duplicating it.
- Investment in the skills, capability, and culture of the Austroads team.



Austroads is owned, directed, and governed by all of Australia and New Zealand's road and transport agencies. Austroads' activities are informed and agreed upon by member organisation participatory forums, such as the Board, task forces, and other collaborative groups. Each member plays a key role in deciding Austroads' priorities and ensuring their success.

We use the acumen and guidance of our members to complement their work and expand good ideas for adoption by all members. In doing so, we apply methodological discipline in delivering to the multiple owners and stakeholders we serve.

We can't deliver good results without a great team that has the right tools and skills, a cando culture, and a positive working environment.

Our can-do team has successfully navigated the complexities of the federation and the road environment to keep delivering.

Our great team and strong culture were recognised with Austroads being named a 5-Star Employer of Choice by HRD Magazine and one of The Australian's 'Best Places to Work 2025'.

We strengthened our organisational digital security by implementing cybersecurity upgrades to ensure we are prepared for evolving challenges. Our work also included the development of a centralised data platform to improve the management and accessibility of transport data.

We provided the right tools, in part by upgrading the analytics platform for heavy vehicle data, enhancing performance and user experience. We fostered a learning culture by providing all staff with access to LinkedIn learning, encouraging specialist training, and ensuring staff had development plans focused on improving their skills.

Our achievements were made possible through collaboration with our member agencies, industry partners, and jurisdictions. As we look ahead, Austroads remains committed to supporting road safety, efficiency, and productivity for the benefit of our members and the communities we serve.

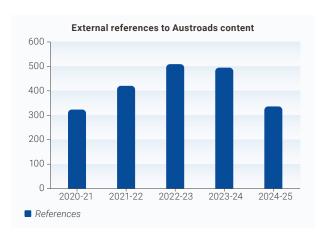


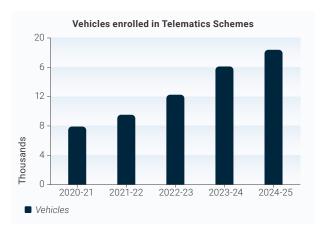


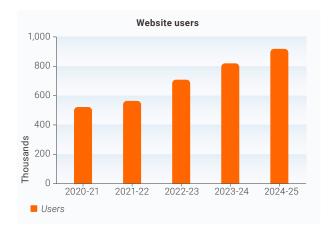














# Who we are

With teams located across Australia and New Zealand, we collaborate closely with member agencies, technical experts, and external partners to deliver high-quality, evidence-based outcomes, such as through our National Telematics Framework (NTF), an internationally recognised operating ecosystem based on productive and structured operational interactions, which continues to adapt and evolve in response to member needs.

Our vision is to be the leading provider of authoritative information, products and services that are adopted and implemented for a safe, efficient, reliable and sustainable transport network across Australasia.

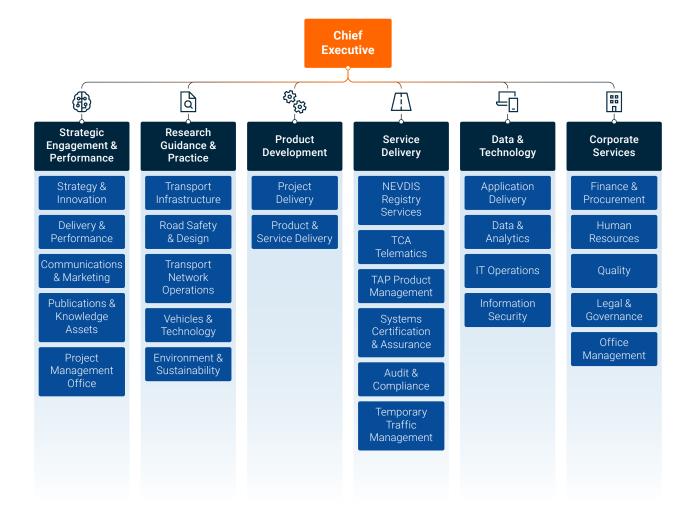
Vision

#### Organisational structure

Following the completion of our organisational restructure in March 2024, Austroads has strengthened its internal alignment, enhanced its capacity to respond to industry expectations, and sharpened its focus on delivering value for members.

We are known as a trusted and influential voice within the transport community as we actively contribute to safer, more efficient, and more reliable transport networks across Australia and New Zealand.

Our new organisational structure fosters greater connectivity across teams, enabling more effective collaboration, knowledgesharing, and delivery of integrated outcomes. It positions us to work more cohesively, both within Austroads and with our partners, to address shared challenges and drive meaningful change.



#### **History**

Since our establishment, Austroads has helped shape Australia and New Zealand's transport landscape by developing and promoting national standards that deliver safer, more efficient, and more sustainable outcomes.

Our journey began in 1933 as the Conference of State Road Authorities (COSRA), formed to coordinate road policy and practice across jurisdictions. Since then, we have expanded our remit and impact, most notably through the integration of the National Exchange of Vehicle and Driver Information System (NEVDIS) and the establishment of Transport Certification Australia (TCA).

Today, Austroads leads complex national projects, undertakes in-depth analysis and research, and supports transport reform and resilience across Australia and New Zealand. The breadth of our role reflects the enduring trust placed in us by our members and Board, and our ongoing commitment to innovation, rigour, and excellence.

# Research and guidance

Austroads undertakes pooled research on behalf of its members to support best practice and future readiness in the transport sector. This includes applied research projects, real-world trials, and the development of technical guidance to support the consistent design, operation, and management of transport networks across Australasia.

Our research priorities are directly informed by member needs and aligned with the directions outlined in our Strategic Plan 2023–27.

#### Our research is delivered through five streams:

- Transport Infrastructure: enhancing the management and performance of physical assets.
- Transport Network
   Operations: improving mobility and accessibility for all users.
- Road Safety and Design: contributing to the elimination of road trauma by 2050.
- Vehicles and Technology: preparing for emerging technologies and their implications for agencies and customers.
- Environment and Sustainability: embedding environmental and sustainability considerations into all aspects of transport decision-making.

#### National data services

Austroads delivers critical transport data services that are essential to keeping people and goods moving safely and efficiently.

Our data services are contemporary, secure, and responsive to evolving needs. Our work encompasses data governance, analysis, reporting, and cybersecurity – ensuring our systems meet global standards and maintain public trust. As custodians of sensitive and personally identifiable information, we are committed to upholding privacy, integrity, and security across all data services.

#### Our key national data services include:

- National Exchange of Vehicle and Driver Information System (NEVDIS)
   Enables the secure exchange of vehicle and licence information across jurisdictions, supporting fraud prevention, vehicle provenance checks, identity matching, insurance processes, and safety recalls.
- Transport Certification Australia (TCA)
   Ensures appropriate data governance and privacy controls through assurance and advisory services, administering the National Telematics
   Framework a government-endorsed platform supporting programs such as the Intelligent Access Program, Telematics Monitoring Application, and the Road Infrastructure Management application.
- Telematics Analytics Platform (TAP)
   Offers authorised users access to aggregated telematics data to support road safety, freight productivity, asset management, and sustainability initiatives.

#### Harmonisation of practice

Austroads leads national initiatives that support the consistent application of best practice across jurisdictions, ensuring transport agencies can operate more efficiently and effectively together. Many of these efforts are initiated at the request of member agencies or ministers and are designed to address shared challenges and deliver nationally consistent outcomes. By reducing duplication, streamlining approvals, and enabling consistent implementation, harmonisation supports improved national economic productivity and better use of public resources.

#### Key examples include:

- development and dissemination of temporary traffic management guidance, training and device assessment
- publication of Austroads' technical specifications
- support for fitness-to-drive assessments and updates to the National Heavy Vehicle Driver Competency Framework
- training related to temporary traffic management, road safety auditing and barrier installation
- prequalification of road and bridge contractors
- delivery of world-class digital driver licence solutions
- launch of national road safety ratings via the Australian Road Assessment Program.

Through these initiatives, Austroads helps align policies and improve safety for road users, agencies, and industry.

This engagement ensures our work remains practical, inclusive, and grounded in the realities of implementation.

• 90 participants joined the 2025 Austroads Bridge Conference's technical tour of Brisbane bridges by river – a unique pre-conference experience facilitated by Austroads, the Queensland Department of Transport and Main Roads, and Brisbane City Council.



#### Task forces

Austroads' task forces are made up of senior representatives from our member organisations who bring deep expertise and practical experience to guide and support our work. Together, our task forces form the foundation of our collaborative model, ensuring our programs are aligned with real-world priorities and grounded in specialist knowledge.

Currently, 12 task forces span the full breadth of our work programs. Each group plays a pivotal role in shaping our agenda through identifying priority issues, developing structured research programs, and putting forward project proposals that respond directly to member needs.

Task forces also play a critical role in ensuring member voices are heard. They facilitate timely and appropriate input into projects and help translate complex ideas into practical, policy-relevant outcomes that inspire action. Our task forces also champion the dissemination of research findings and project deliverables, supporting the uptake of insights across road agencies and related organisations. These groups are crucial forums for knowledge exchange, bolstering connections between Austroads' members and partner organisations to enable continuous learning across the sector.

We are deeply grateful for the dedication and expertise of our task force members – their contribution is essential to Austroads' impact and success.

#### Driving global best practice

The World Road Association (PIARC) brings together experts from over 120 countries to share knowledge and develop best practice in road transport, focusing on safety, sustainability, resilience, and innovation.

Australia and New Zealand contribute to this global effort through active participation in PIARC's technical committees, task forces, and special projects, with outcomes reported at the World Road Congress every four years. Louise McCormick (Austroads Chair) and Brett Gliddon (Austroads NZ Board member) serve as First Delegates, and Austroads Chief Executive Dr Geoff Allan is Vice President of PIARC and Chair of its Strategic Planning Commission.

### Strategic engagement in North America

In 2025, Austroads Board members undertook a strategic engagement program in Washington, D.C., meeting with the American Association of Motor Vehicle Administrators (AAMVA), the US Federal Highway Administration (FHWA), and the American Association of State Highway and Transportation Officials (AASHTO). The delegation contributed to high-level discussions on digital fraud, advanced vehicle technologies (including ADAS), and driver licensing reforms. Site tours of major transport infrastructure provided valuable insights into sustainable mobility initiatives and long-term investment strategies.

As part of the visit, Austroads and AASHTO signed a memorandum of understanding to formalise their commitment to ongoing collaboration. The agreement outlines shared priorities that will deliver direct value to members, including access to joint research on emerging challenges, opportunities to participate in international knowledge exchange, and pathways for professional development through cross-network events. This partnership enhances Austroads' ability to connect members with global expertise, strengthen strategic alignment, and inform local policy and practice with international insights.

# Enhancing infrastructure decision making in Cambodia

Austroads have continued working with the Cambodian Government to support improved decision making, facilitate capacity building and establish contemporary, fit-for-purpose and adaptable technical specifications. Austroads work with Cambodia is a governmentto-government initiative under the Partnerships for Infrastructure program, supported by the Australian Government. In March 2025, Austroads leaders visited Cambodia to wrap up phase 1 of work with the Ministry of Public Works and Transport Cambodia. This work involved updating the bridge and road technical specifications to improve the construction and maintenance of road infrastructure. The handover ceremony received media coverage in Cambodia, with the Cambodian Minister and Australian Ambassador also announcing the launch of Australia's second phase of support for Cambodia. Austroads is currently undertaking work for phase 2.

# International recognition for leading road design research

Austroads' research program is recognised internationally as a trusted source of insight and guidance. This reputation was reinforced when a joint paper by Austroads and the Victorian Department of Transport and Planning won a Best Paper Award at the Transportation Research Board's 7th International Conference on Roundabouts and Geometric Design in Atlanta, USA.

The paper, Addressing the Current and Future Needs of Road Design in Australia, was authored by Richard Fanning and Philip Rosser from the Victorian Department of Transport and Planning, along with Michael Nieuwesteeg and Paul Davies from Austroads.

It explores practical strategies and forward-looking insights into Australia's evolving approach to road design. The paper was led by Philip and Richard, with support from the Austroads Road Design Task Force.



#### A landmark year for knowledge sharing

The 12th Austroads Bridge Conference was a standout moment of 2024-25, setting a new benchmark for innovation, collaboration and engagement in bridge engineering.

Held in Brisbane in June 2025, the conference brought together:

- over 600 attendees from across Australia, New Zealand and internationally
- nearly 300 technical papers delivered across five specialist streams
- more than 170 speakers, showcasing research, innovation and industry leadership.

This was the largest Bridge Conference in Austroads' history, reflecting the scale, diversity and depth of expertise within the bridge engineering community.

Thanks to the contributions of sponsors, speakers, exhibitors and attendees, the event was a resounding success — a vital platform for sharing knowledge, strengthening professional networks, and shaping the future of bridge design, construction and maintenance.

### **Governance frameworks**

Austroads uses a robust suite of governance frameworks, methodologies, and policies to make data-driven, evidence-based decisions and ensure continuous improvement, accountability to our stakeholders, and strategic responsiveness.

### ISO compliance

TCA holds ISO 9001:2015 and ISO 27001 certifications. In October, TCA successfully upgraded its ISO 27001 certification from the 2013 standard to the latest 2022 standard. The TCA laboratory holds NATA accreditation (ISO/IEC 17025).

### Project funnel

A key governance advancement over the previous financial year has been the maturation of our product development funnel – a framework designed to identify, assess, and prioritise innovation and ideas for development. The process is supported by a reporting dashboard, established in 2024.

Importantly, the funnel enables us to support our members in ways that extend beyond the formal research program, creating space for agile, forward-looking initiatives. As the funnel continues to evolve, it is proving effective in helping Austroads respond to growing demands and enhance our innovation capacity.

### Risk management

Our Risk Management Committee (RMC) meets three times a year and reports to the Board on key strategic and enterprise risks. A Strategic and Enterprise Risk Report, updated for each RMC meeting, includes risk tolerance, target levels and mitigation measures.

The Austroads Executive Group (AEG) reviews organisational and strategic risks on a regular basis. AEG members are responsible for managing, identifying and reporting risk from their areas and risks are reviewed at the AEG monthly meeting. The TCA Certification and Risk Committee (TCA CARC) reviews risks and mitigations specific to TCA when it meets quarterly.

### Information security

Austroads is building a secure and resilient environment designed to safeguard our systems, data, and people against a range of risks, including cyber incidents, data loss, human error, and the evolving demands of a complex digital landscape. Guided by our information security strategy, we are fortifying every layer of our operations to ensure the confidentiality, integrity, and availability of critical information. Through regular communication, training, and team engagement, we are building a strong cyberaware culture. Our growing security team supports this vigilance, ensuring that everyone has the tools and knowledge required.

### Austroads' information security strategy focuses on:

- protecting the privacy of sensitive information held by Austroads
- delivering services that are resilient to cyber-attacks and can be quickly recovered if interrupted
- ensuring our digital communications channels are trustworthy and free from manipulation.

Information security at Austroads is a shared duty that extends across the entire organisation. Every staff member, contractor, and partner involved in designing, managing, or using digital systems plays a key role in protecting the organisation and its stakeholders.

### To support this shared accountability, Austroads has implemented measures to ensure:

- all staff and contractors receive tailored training and practical guidance to reduce cyber risks
- business units and application owners are directly responsible for protecting the systems and data they manage
- security is embedded into everyday decision-making, projects, and operational processes.

#### Our improvements include:

- expanding the security team
- expanding our security capabilities through managed security service providers
- updating and expanding our policies and procedures while maintaining our ISO 27001 compliance for Transport Certification Australia
- standardising and strengthening security measures across the organisation.

### Portfolio, Program and Project Management Framework

In 2024, Austroads Project
Management Office (PMO)
established a unified, organisationwide project management system
that brings together all essential
policies, processes, and tools.
The Portfolio, Program, and
Project Management Framework
is a comprehensive system that
standardises project management
practices across the organisation.

This Framework supports informed decision-making by Austroads senior leadership, particularly in identifying and managing project risks and issues. Of the 16 intended modules, 14 have been implemented as at 30 June 2025. The PMO's expanded role now includes maintaining the standardised framework, as well as centralising project reporting and performance monitoring throughout Austroads.

#### National Telematics Framework

The National Telematics Framework (NTF or the Framework) is an internationally recognised operating ecosystem which continues to adapt and evolve in response to the needs of Austroads members, government agencies, telematics providers and road users.

### At the centre of the Framework is the structured operational interactions between:

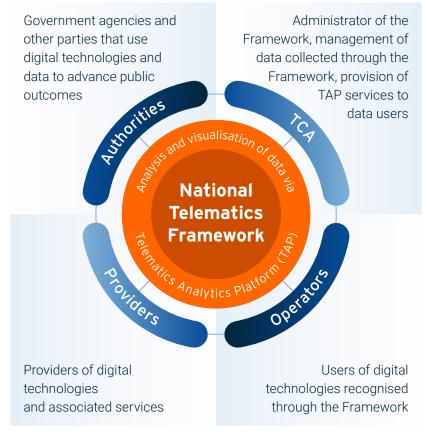
- authorities (Austroads members and other government agencies)
- telematics providers (application service providers)
- road users (registered operators of vehicles)
- TCA (the government-appointed administrator of the Framework).

These interactions enable authorities to activate new policies and programs to collect data from in-vehicle technologies to improve productivity, safety and sustainability.

### Setting the global benchmark: Framework adopted as international standard

TCA developed the Framework in Australia in 2009 following a series of ministerial decisions between 2003 and 2008. The Framework was so successful that in 2012 it was adopted as an international standard ISO 15638.

TCA continues to lead developments of the standard, with updates being made in collaboration with national and international ISO committees during 2024–25. This ensures the National Telematics Framework, and its relationship with international standards, continues to lead the world.

### Recognition for excellence in reporting

Austroads commitment to good governance was recognised with a Silver Award in the 2025 Australasian Reporting Awards (ARA) for our 2023–24 Annual Report. To receive a Silver Award, a report must demonstrate high-quality coverage of the general criteria, provide clear disclosure of key aspects of the organisation's performance, and deliver outstanding transparency in at least one major area.

This recognition reinforces Austroads dedication to maintaining high standards in corporate reporting and strengthens confidence in the organisation's governance and accountability to stakeholders.

### Internal transformation projects

We are reshaping our digital foundations to deliver smarter, more connected services for our members.

Austroads is investing in modern systems and practices to uphold the integrity, safety and trust that underpin our work. These internal transformation projects are strengthening our data integration, uplifting security procedures and reshaping how we communicate across digital platforms.

Together, they will enhance our relationships with stakeholders, improve privacy and data governance, and deliver more efficient, reliable and user-focused services for our members.

### Strengthening data integration

To deliver actionable, trusted data for the transport sector, Austroads is developing a modern, centralised data platform using Databricks technology.

This initiative tackles the longstanding challenge of fragmented transport data — information collected over nine decades but dispersed across multiple systems and formats.

### The new platform will serve as a central landing zone for all datasets, enabling:

- centralisation and standardisation of data
- · greater accessibility for members
- stronger governance and security frameworks.

Consolidating data in one unified platform will improve consistency, accuracy and compliance, while making it easier for members to access and use valuable information. The platform is currently under development and scheduled for completion by the end of 2025.

### Laying the foundations for a smarter digital knowledge system

As part of a broader digital transformation, Austroads has launched a multi-stage initiative to modernise how technical knowledge is delivered and accessed across the transport sector.

Austroads' extensive library of guides, specifications and test methods underpins industry practice. This project is reimagining how that knowledge is structured and delivered to make it more dynamic, accessible and user-friendly.

The first stage, which began in early 2025, has focused on research, planning and solution design. A Project Control Group is overseeing delivery to ensure expert input and user feedback guide the process. Extensive consultation with internal users has been central to shaping the vision for a more intuitive and efficient knowledge platform.

### Key deliverables from this stage include:

- a market review of industry best practice
- a proof of concept for core system functionality
- a detailed design for a new Content Management and Delivery System.

These milestones are laying the groundwork for the next phases of implementation, positioning Austroads to create a smarter, digitally enabled knowledge platform for the transport sector.

# Conducting rigorous, member-focused research

Austroads delivers high-quality, practical research that helps members address shared challenges and build better transport systems.

Our work focuses on the issues that matter most to transport agencies — improving safety, advancing sustainability, boosting productivity and embracing innovation — and supports consistent, evidence-based decision-making across Australia and New Zealand.

### Road safety

### Keeping people safe when walking

Pedestrian deaths and serious injuries remain far too high. Austroads published four new reports that give road safety professionals a clear roadmap to reduce harm, especially for children, older people, First Nations communities and people with disability.

Grounded in Vision Zero principles, the work identifies 54 proven safety measures and shows how a system-wide approach could cut pedestrian deaths and serious injuries by up to 90 per cent. The next phase will benchmark current practices across jurisdictions and highlight successful local implementations.

### Reducing head-on crashes on high-speed rural roads

Head-on crashes on high-speed, two-lane rural roads are often fatal. Austroads research identified flexible safety barriers in wide medians as the most effective treatment and recommended their wider use regardless of median width.

Where barriers are not feasible, alternatives such as wide centre lines and audio tactile line markings may be suitable depending on road function, space and resource constraints.

### **Facilitating practical** action on safer speeds

Speed is a key factor in crash likelihood and severity. Austroads published a report featuring 28 case studies showing how safer speed limits are being introduced to reduce road trauma and improve community wellbeing.

The report highlights how data, community engagement and strong partnerships can shift public sentiment and deliver safer, more liveable streets.

### Improving safety guidance for specialty vehicle harnesses and vests

Children and young people with disability often rely on specialty harnesses and vests for safe vehicle travel, yet current guidance is limited. Austroads engaged Mobility and Accessibility for Children and Adults (MACA) to review the current landscape across Australia and New Zealand, drawing on surveys, expert input and product analysis.

The research calls for clearer guidance, stronger collaboration between regulators, health professionals and manufacturers, and a review of relevant laws and standards to better support families.

### Implementing Assessing Fitness to Drive standards

Consistent health-based assessments of drivers are essential to road safety. Austroads has made strong progress in the first year of implementing the national Assessing Fitness to Drive standards, developed by the National Transport Commission and published by Austroads.

Work has focused on communication, education and systems, supported by a dedicated website, quarterly newsletters and targeted outreach. New projects include an education module for general practitioners and a scoping study for national occupational therapy guidelines.

### Informing policy development for overseas-licensed heavy vehicle drivers

To support safe and efficient workforce participation, Austroads surveyed more than 1,900 overseas-licensed heavy vehicle drivers to understand their challenges driving in Australian conditions.

Findings highlighted issues around Australian road rules, English language proficiency, and experience with large combination vehicles. Insights are informing policy options currently under consideration by jurisdictions.

### Charting a path for lifesaving automatic crash notification systems

Automatic Crash Notification (ACN) technology can save lives by automatically alerting emergency responders after a crash. While increasingly present in vehicles and smart devices, ACN is not yet widespread.

This Austroads research examined technology options, policy pathways, costs and international lessons (including the EU's mandated eCall system) to help governments and agencies scale ACN systems and realise their life-saving potential.

# Equipping planners to improve cycling and micromobility networks

E-scooters, skateboards, kick scooters and other micromobility devices are increasingly part of daily travel. Austroads commissioned new guidance to help transport planners design safer, more inclusive networks for this growing mix of users.

The report sets out practical steps to make streets safer and more accessible for people of all ages and abilities, aligns with international best practice, and introduces a glossary of common terms to support consistent planning approaches.

# Setting clearer direction for applying Movement and Place thinking

Roads serve as both corridors for efficient movement and as public places that support community life. To improve consistency in applying Movement and Place principles, this project reviewed existing guidance, consulted widely with stakeholders, and developed a common set of terminology, core framework elements and clearer direction for road managers.

The framework helps balance the needs of different users, modes and places, and lays the groundwork for future updates to Austroads' Guide to Traffic Management.

### Identifying critical lifeline routes

Many rural and remote communities rely on single road connections to maintain access during emergencies. These "lifeline routes" are vital for safety, supply chains and community resilience, but their broader social and economic value has been difficult to capture in investment decisions.

Austroads updated its Lifeline Risk Indicator Tool to help road managers identify and prioritise these routes. The tool ranks their significance and risk reduction benefits, supporting investment decisions that strengthen critical freight and community links.

# Offering practical solutions for climate-resilient asset management

Climate change is increasing the frequency and intensity of extreme weather events, placing growing pressure on transport networks.

Austroads commissioned research to provide practical strategies for asset managers to build resilience into their systems and practices. The resulting guidance offers actionable recommendations on asset lifecycles, criticality and vulnerability assessments, climate resilience valuation, and asset information management, supported by adaptable case studies from across the sector.

### **Enhancing climate risk** planning

Traditional infrastructure design often relies on historical climate data, which is no longer a reliable predictor of future conditions.

Austroads commissioned the development of common guidance aligned with the latest industry best practice and policy settings to support transport agencies in assessing climate and natural hazard risks. The guidance provides consistent recommendations and examples that apply across all transport-related assets and services, from roads and rail to aviation, maritime, utilities and active transport.

### Decarbonising Australia's road freight

Transitioning to low and zero-emission heavy vehicles is essential to meet net zero targets, but these vehicles are often heavier than traditional trucks and can accelerate road wear.

Research commissioned by Austroads explored policy and technical options to support freight decarbonisation while protecting pavement and bridge infrastructure.

The work identifies potential pathways including adjusted mass limits, redistributing axle weights and adopting international best practices to balance environmental goals with infrastructure sustainability.

# Reducing the environmental footprint of sprayed seals

Sprayed seals cover around 70 per cent of sealed roads but rely heavily on non-renewable materials.

Austroads commissioned research to identify ways to lower their environmental impact and support jurisdictions to meet climate objectives.

The report outlines innovative alternatives to traditional bitumen binders — such as emulsions, bio-binders and additives — and explores advances in aggregates, precoating methods and equipment to reduce emissions and resource use.

# Proving the effectiveness of crumb rubber from non-truck tyres for paving

Crumb rubber from truck tyres is commonly used in asphalt mixes, but material from passenger car and off-the-road (OTR) tyres is underused.

Austroads led a demonstration project that resurfaced a Tasmanian road with asphalt incorporating crumb rubber from passenger car, truck and OTR tyres.

Testing showed comparable performance across all mixes, supporting the potential for greater use of recycled materials and advancing the circular economy in road construction.

# Bolstering the longevity and cost-effectiveness of pavement rehabilitation

Reflective cracking limits the lifespan of pavement overlays, driving up maintenance costs.

Austroads commissioned research to refine asphalt overlay design and improve long-term pavement performance.

The findings suggest potential to reduce the current minimum 175 mm overlay thickness in hotter climates, and indicate that the existing weighted mean annual pavement temperature (WMAPT) method may not reliably predict reflective cracking.

While results are promising, further research across a wider range of Australian and New Zealand climates is needed before formal design guidance can be updated.

# Introducing a new storage stability test for hybrid polymer modified binders

Next-generation hybrid polymer modified binders (PMBs) offer performance benefits but have outpaced current storage stability tests.

In response, Austroads developed ATM 104 Storage Stability of Binders — a new method based on international best practice and adapted from the European EN 13399 standard.

ATM 104 offers improved sensitivity, reduced binder oxidation and better safety outcomes, helping industry ensure consistent quality during storage and transport.

# Upgrading existing tunnels to energy-efficient LED technology

Many older tunnels still rely on energy-intensive lighting systems nearing end of life. Austroads commissioned guidance to help tunnel owners and operators upgrade to energy-efficient LED lighting.

The report outlines best practice design, technical specifications, installation methods, and highlights the value of early planning and stakeholder coordination to achieve up to 20 per cent energy savings and improved safety outcomes.

### Informing workforce planning to deliver road projects

With road infrastructure investment at historic highs, agencies face growing competition for skilled workers.

Austroads commissioned research to help members understand and plan for emerging capability gaps, particularly short- to medium-term pressures in Victoria, South Australia, the Australian Capital Territory and New Zealand.

The work forecasts a temporary gap of over 300 workers in New Zealand's public road workforce by FY27 and highlights ongoing demand for road construction, maintenance and delivery programs across Australia, supporting targeted recruitment, training and migration strategies.

### Improving processes for effective road design

Designers are operating in increasingly complex and constrained environments, making it vital to balance flexibility with safety and performance.

Austroads published key updates to the Guide to Road Design to support better decision-making in these contexts.

- Part 1: Objectives of Road Design
   introduces structured definitions for
   Extended Design Domains and Design
   Exceptions, giving practitioners clearer
   guidance on managing designs that fall
   outside typical standards.
- Part 5A: Drainage Road Surface, Networks, Basins and Subsurface provides practical advice on designing drainage systems to collect and discharge water effectively, covering surface drainage, pit and pipe networks, basins and subsurface drains.
- Part 6: Roadside Design, Safety and Barriers outlines how to assess roadside hazards and select appropriate safety barrier systems, including methods for evaluating treatment effectiveness.

These updates support practitioners to make informed, risk-based decisions that maintain safety, operational performance and whole-of-life value.

# Providing a unified design process for bridge barriers

Bridge barriers are critical to protecting lives, yet practices for their design have varied across jurisdictions.

Austroads developed updated national guidelines to support a more consistent, evidence-based design process.

The guidelines cover barrier types, materials, transitions, Safe System alignment and crash modelling. They are informed by extensive consultation, advanced modelling and a world-first full-scale crash test of a 36-tonne articulated truck, a sports utility vehicle and a small passenger car — all at 90 km/h, exceeding international performance standards.

This work will improve safety and consistency in bridge barrier design and strengthen confidence in infrastructure delivery.

# Helping road agencies reduce road trauma using Safe System principles

Reducing road trauma requires continually evolving guidance that reflects best practice.

Austroads updated key parts of the Guide to Road Safety to give practitioners, planners and decision-makers practical tools for embedding Safe System principles.

- **Part 2** now includes a broader range of treatments, from intersection upgrades to measures that better protect people walking and cycling.
- Part 7 has been expanded to cover networkwide safety planning, future-state modelling and movement and place frameworks.

The updates support a more holistic approach to safety and make it easier for local governments to address road trauma on local roads, where risk is highest.

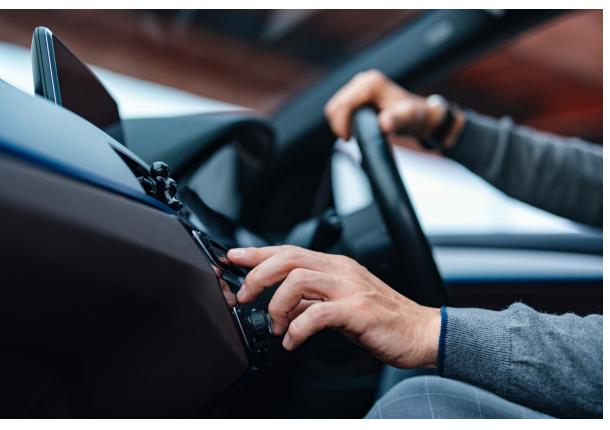

Austroads guidelines aim to improve the safety, consistency, and cost-effectiveness of bridge barrier design across Australia and New Zealand.



The Austroads guideline marks an important advancement in increasing awareness and reducing instances of distracted-driving accidents on Australian and New Zealand roads.

### Promoting a systemsbased approach to reducing driver distraction

Driver distraction contributes significantly to road crashes, and up to 30 per cent of distraction-related crashes stem from external factors beyond the driver's control.

To support a more consistent response, Austroads developed national guidance aligned with the National Driver Distraction Roadmap.

The guideline provides governance and implementation tools to help agencies and organisations adopt a systems-based approach to reducing distraction, shifting the focus from individual behaviour to broader design and operational factors.

### Launching digital engineering guidance

Digital engineering (DE) is transforming how transport agencies design, deliver and manage infrastructure, improving productivity, efficiency and sustainability. To support consistent, effective use across jurisdictions, Austroads developed the Guide to Digital Engineering in collaboration with government, industry, and specialist groups.

The guide provides step-by-step support for agencies at all stages of DE adoption, from early pilots to mature systems. It promotes alignment with open standards such as openBIM, encourages collaboration, and supports better decision-making through improved use of data and interoperable systems.

This national approach will help agencies harness the full benefits of digital engineering and improve the long-term management of transport assets.

Consistent, high-quality asset data is essential for informed decision-making, efficient reporting and effective use of funding. Austroads developed practical tools to support member agencies in adopting the Road Asset Data Standard (RADS).

These resources provide guidance on the benefits of RADS, timing for system updates, and step-by-step adoption processes, along with structured checklists and data mapping templates aligned with funding and reporting requirements.

This work supports agencies to align local data practices with a national standard, improving data quality, enabling better decision-making and simplifying reporting.

### Guiding sustainable practices for road tunnels

Road tunnels are long-term assets expected to operate well beyond 2050, making it vital to embed sustainability from design through to operation. Austroads updated the Guide to Road Tunnels to provide practical advice on addressing environmental, social and economic sustainability across every stage of a tunnel's life cycle.

The new Part 1 defines sustainability and outlines its importance, while Parts 2, 3 and 4 provide detailed benchmarks for planning, design, commissioning, operation, maintenance and retrofitting.

These updates will help tunnel owners and operators reduce emissions, enhance environmental quality and support community wellbeing throughout the asset lifecycle.

# Mapping temperature changes for long-lasting asphalt pavements

Rising temperatures linked to climate change are affecting the performance and durability of asphalt pavements. To support climateresilient design, Austroads released an interactive map of the latest Weighted Mean Annual Pavement Temperature (WMAPT) data for around 250 locations across Australia and New Zealand.

This resource gives pavement engineers the temperature insights they need to select materials and structural designs suited to local conditions, and will soon incorporate projected WMAPT values to guide long-term planning.

### Enhancing road construction practices with new test methods

Road construction faces growing pressures to reduce emissions and safely incorporate recycled materials. To help the industry respond, Austroads introduced four new test methods developed with broad industry and government input.

These methods measure emissions from bitumen and asphalt during heating, assess microplastic release from plastic-modified asphalt, and evaluate the impact and suitability of recycled plastics in paving materials. They give agencies and suppliers practical tools to improve environmental management, material safety and sustainability outcomes.

# Strengthening national consistency in temporary traffic management

Improving safety for road workers requires consistent training and practice across all jurisdictions. Austroads delivered a major update to the Guide to Temporary Traffic Management Part 8: Temporary Traffic Management Categories and the National Training Framework, introducing a nationally harmonised approach to training and accreditation.

The update refines temporary traffic management categories, clarifies roles and responsibilities, and sets out structured pathways for qualifications across Traffic Controller, Traffic Management Implementer and Traffic Management Designer roles.

This harmonised framework is now operational in South Australia, Victoria, Northern Territory and Tasmania, helping build a mobile, skilled and safety-focused workforce.

### Updating the process for recognising overseas driver licences

The role of international driver licences has become increasingly complex, creating new risks around identity fraud, document security and mobility. To address this, Austroads reviewed and updated the Recognised Country Scheme, which sets the standards and processes for recognising overseas licences across Australia.

The update introduced revised arrangements for issuing comparable Australian licences, a new application process for countries seeking inclusion, and scheduled five-yearly reviews of recognition status.

This strengthens safety, integrity and consistency across Australia's licensing system.

# Refining national heavy vehicle training and assessment materials

Heavy vehicle driver training, assessment and licensing currently vary across Australia, resulting in inconsistent safety and competency standards.

Austroads has drafted new training and assessment materials to support a nationally consistent approach, developed in collaboration with state and territory agencies and industry.

These materials are now under industry review to ensure they are practical and fit for purpose. Once refined, they will be tested and trialled ahead of planned national implementation from late 2026.

# Delivering trusted operational and data services

Austroads delivers national systems and safety frameworks that underpin the daily operation of Australia and New Zealand's transport networks. From secure data exchange and digital licensing to harmonised training and safety standards, these services enable agencies to work seamlessly across borders, strengthen compliance, and improve safety, efficiency and consistency across the network.

### National vehicle and driver information services

Austroads operates a suite of interconnected national systems that provide secure, realtime exchange of vehicle, driver and heavy vehicle data. These services underpin crossborder licensing and registration, enable secure digital credentials, and power the telematics data that is transforming how road networks are managed.

### **NEVDIS - Keeping** vehicle and licence data secure and connected

The National Exchange of Vehicle and Driver Information System (NEVDIS) underpins the integrity of Australia's licensing and registration systems, providing real-time exchange of vehicle and licence information between jurisdictions. It ensures 'one vehicle, one Vehicle Identification Number' and 'one person, one driver licence', preventing fraud, theft and duplication across borders.

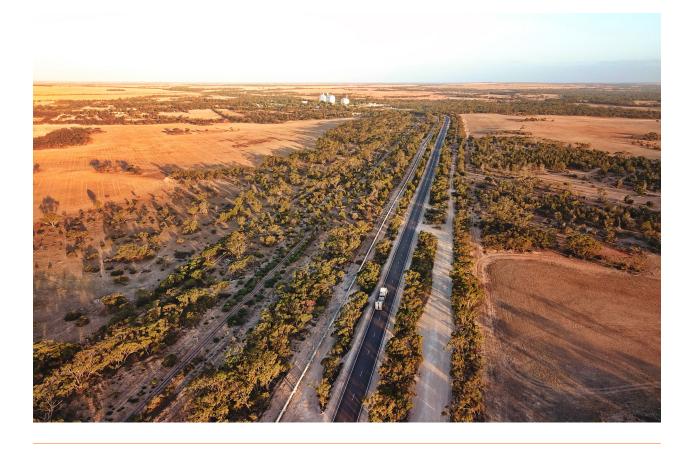
NEVDIS also supports a wide range of public and private sector services – from vehicle provenance checks and licence biographic matching to insurance underwriting and safety recalls - helping industry and government make safe, informed decisions.

This year, the rollout of the new Licence Infringement Portal marked a major milestone. Built using multi-factor authentication, encryption and address whitelisting, the portal enhances jurisdictions' ability to manage infringement notices and penalties securely and efficiently.

### DTS – Enabling mobile driver licences and digital credentials

Austroads is leading a major trans-Tasman program to enable the secure roll-out of ISO-compliant mobile driver licences (mDLs) across Australia and New Zealand. The project will allow licence-holders to store and present their licences in smartphone wallets, while giving governments and third parties the ability to securely verify them using the new Digital Trust Service (DTS).

The DTS builds on NEVDIS infrastructure to provide cross-jurisdiction verification, privacy protection and fraud prevention. At the IVC24 Summit in Sydney, live demonstrations showed how digital driver licences and other credentials could be instantly verified using the DTS, confirming the service is ready to scale.

Roll-out is scheduled for the next financial year, marking a major step forward in delivering trusted, privacy-preserving digital credentials to support safer, more efficient transport systems.

### TCA – Powering trusted telematics data services

Telematics Certification Australia (TCA) delivers the National Telematics Framework (NTF), which securely collects and manages heavy vehicle data from across the country. This trusted framework enables governments and industry to monitor heavy vehicle movements, improve access decisions, inform infrastructure planning and adopt modern, risk-based approaches to managing road use.

#### In 2024-25:

- · Vehicle enrolments grew by 14%
- Four new application service providers were certified Geotab Australia, MiX Telematics Australasia, Netcorp GPS and Tramanco
- One new Road Infrastructure Management provider was approved — Australian Transport Compliance Centres Pty Ltd
- Two new telematics devices were type-approved from Teltonika Australia (available to multiple providers) and Directed Electronics (used as OEM equipment in vehicles).

TCA also partnered with NZ Transport Agency Waka Kotahi to pilot the NTF in New Zealand, demonstrating the value of telematics data for planning and managing heavy vehicle movements.

### TAP - Transforming how road managers use data

The Telematics Analytics Platform (TAP) is the primary gateway to the NTF, transforming location and mass data from over 19,000 vehicles, collected as often as every 30 seconds, into actionable insights for transport agencies, road managers and researchers.

#### Major milestones this year included:

- Faster insights: a major modernisation initiative reduced data latency from eight weeks to just hours, giving road managers access to last week's data rather than last month's
- System upgrades: TAP received a refreshed user interface, improved load performance and rigorous stress testing to support a substantial increase in monitored vehicles
- Enhanced geospatial capability: integration of Austroads' broader research datasets now gives users richer spatial insights, supporting better investment decisions and improved lifecycle planning.

TCA safeguards vehicle data and operator privacy by aggregating and de-identifying data, ensuring TAP delivers high-value insights while maintaining the highest standards of information integrity and operational resilience.

The Framework ensures consistent training to a recognised industry standard and promotes safety at worksites

### National operational safety frameworks

Austroads delivers national frameworks that lift safety standards, harmonise training and accreditation, and accelerate adoption of safer roadside technologies.

These initiatives give jurisdictions consistent tools and trusted processes to protect workers, road users and communities.

### **National Training Framework for Temporary Traffic Management**

### Lifting safety standards in temporary traffic management

Improving safety at road worksites depends on consistently high training standards. Through the National Training Framework for Temporary Traffic Management (NTFTTM), Austroads provides nationally harmonised training, qualifications and technical guidance for those managing traffic on and around roads.

Developed with state and territory transport agencies, industry and Registered Training Organisations (RTOs), the training, combines classroom-based theory and on-the-job training, aligned to nationally accredited skill sets, the Guide to Temporary Traffic

Management and jurisdictional requirements. It offers structured pathways across Traffic Controller, Traffic Management Implementer and Traffic Management Designer roles, supporting a genuine career structure.

Since adoption in South Australia, Northern Territory, Tasmania and Victoria, record enrolments and strong feedback have confirmed the NTFTTM's effectiveness in improving knowledge, site safety and workforce mobility. A robust audit framework applies consistent, risk-based methods to ensure approved training providers and trainers meet national standards, strengthening industry confidence and accountability.

# AITDSA – Accelerating innovation in traffic management safety

The Austroads Innovative Temporary Traffic Management Device and Solution Assessment (AITDSA) scheme helps members identify and adopt safer, more effective technologies for static and mobile traffic management. AITDSA provides a nationally consistent process for evaluating new devices, enabling jurisdictions to make informed decisions about trialling or implementing them.

As of June 2025, seven devices have been recommended for use through AITDSA, helping agencies adopt innovation with confidence.

### ASHTAS – Ensuring quality and consistency in barrier installation

The Austroads Safety Hardware Training and Accreditation Scheme (ASHTAS) sets the benchmark for training in the design, installation and maintenance of roadside safety barriers.

It is now mandatory in New Zealand and six Australian jurisdictions, with more than 1,000 participants trained by five approved providers.

ASHTAS starts with fundamental training in safety awareness and barrier installation, then offers specialist modules on specific barrier types and proprietary systems, ensuring consistent competence across the industry.

### ASBAP – Assuring the safety of roadside barrier systems

Run-off-road crashes are among the most common crash types. The Austroads Safety Barrier Assessment Panel (ASBAP) helps agencies reduce this risk by assessing the crashworthiness and suitability of roadside safety barrier systems and devices, and providing shared technical advice to participating jurisdictions.

This removes the need for each jurisdiction to conduct separate assessments, ensuring consistency and reducing duplication.

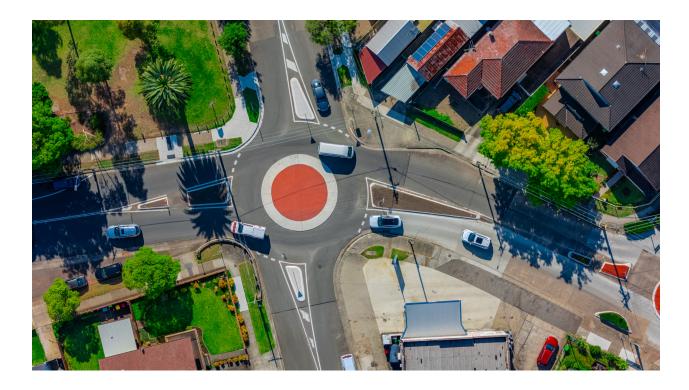
As of June 2025, ASBAP has issued 16 technical advice documents, covering topics such as barrier heights, crash cushions, public domain transitions and finite element analysis.

### AusRAP - Targeting investment to save lives

Improving road safety requires transparent, accessible data to guide investment in higherrisk roads. The Australian Road Assessment Program (AusRAP) star-rates roads from 1 to 5 stars based on their built-in safety using the globally recognised iRAP methodology. Each additional star halves the risk of death or serious injury, with roads rated 3 stars and above recognised as safer.

Comprehensive crash and star rating data has been compiled into a new national AusRAP dashboard, scheduled for launch in late 2025. This work supports national goals to ensure 80% of travel occurs on 3-star or better roads by 2030, and to eliminate deaths and serious injuries on Australian roads by 2050.

### Harmonising road safety audit practice

To strengthen national consistency and transparency, Austroads is leading the National Harmonisation of Road Safety Audit Practice project. This initiative will align processes and IT systems for managing accredited road safety auditors, streamlining key tasks such as applying for changes in auditor status and completing renewals.

Victoria has already adopted Austroads' IT platform to manage its auditors, and the full national harmonisation project is on track for completion by late 2026.

## **Strategies**

Austroads Strategic Plan 2023–27 establishes the strategic directions and actions the company will progress. In pursuit of its vision to be the leading provider of authoritative information products and services that are adopted and implemented for a safe, efficient, reliable and sustainable transport network across Australasia, Austroads will:

- Conduct research that is coordinated and pooled, has scientific rigour, and directly addresses issues of concern to our members
- Provide authoritative guidance and facilitate the consistent and effective implementation of best practice
- Develop new and enhanced services to improve outcomes for our members and key stakeholders
- Provide operational services that are trusted, effectively managed and continually improved
- Manage transport information and data services that are contemporary and keep pace with evolving trends
- Be an exemplar model of a well-run member organisation that provides services to and on behalf of government transport agencies.

An annual business plan, which is monitored and reviewed by the Austroads Executive Group, is Austroads' principal planning document. It sets the framework for the delivery of value for its members by directly connecting Austroads' activities and our people to Austroads' objective, to solve problems for transport agencies in Australia and New Zealand.

# Key performance measures

An overview of performance, including five-year trends, is included on pages 7 to 10 (Our impact). The following measures have been developed to assess performance and progress against the delivery of actions identified in each of the Company programs:

# Projects and services delivered on time, on budget, and in line with stakeholder requirements.

Austroads had 135 projects underway or commence in 2024–25 financial year, including 32 projects that were completed. At the end of the financial year, there were 103 active projects, 83 of those were on track for completion on schedule. A further 20 are at risk of delay against scheduled completion dates, these projects have had internal project milestones delayed but there are no current effects on scheduled completion dates. Projects were completed within the total project budget.

## Increased adoption and use of our information products and services.

Austroads member agencies have adopted nine Austroads Guides:

- Guide to Asset Management
- Guide to Bridge Technology
- · Guide to Pavement Technology
- Guide to Project Delivery
- Guide to Road Design
- Guide to Road Safety
- Guide to Road Tunnels
- Guide to Smart Motorways
- · Guide to Traffic Management

The new Guide to Digital Engineering was published in December 2024. It was downloaded more than 1,000 times.

Austroads Guides are increasingly used by members and the broader industry. More than 366,000 copies of the Austroads Guides were accessed during the year, a 9% increase on the previous financial year and a 38% increase on 2020-21. The Guides, which cover the planning, design, operation and management of road infrastructure, are used extensively in Australia and New Zealand but their quality is recognised internationally.

# Greater proportion of information products provided in contemporary digital formats and efficient self-serve access.

A project has been established to deliver the Austroads Guides and technical specifications in an online digital format. The project will replatform the Austroads website to enable more flexible use of content and an improved user experience. A consultant has been engaged to help identify user requirements, develop a new information architecture and undertake a product comparison.

# Increased number of research and trial projects progressed to implementation and ongoing services.

During the year Austroads transitioned two projects to operational services: Recognition of Overseas Driver Licences and Assessing Fitness to Drive Medical Standards. Substantial progress was also made to deliver the ADAS Guidance Service which was launched in September 2025.

Work continues on the plan to deliver extensive programs of work to review and improve the National Heavy Vehicle Driver Competency Framework and deliver a new Digital Trust Service. As with any national reform, these long-term programs of work, require engagement and consultation with multiple stakeholders across all jurisdictions. Stages will be rolled out over the next few years.

## Expanded range and number of vehicles enrolled in TCA-administered applications.

At the end of the 2024–25 financial year 18,403 vehicles were enrolled in TCA-administered schemes. This is a 9% increase on the previous year and a more than 130% increase over the past five years.

# Assurance functions expanded across a broader range of providers, products and services.

Austroads is continuing to develop a national Product Type Approval Framework, complemented by nationally harmonised adoption of specifications.

NEVDIS services expanded, while continuing to meet core availability and transactional targets.

As an example of the expansion of NEVDIS services, the new Licence Infringement Portal was launched this year. Incorporating multi-factor authentication, encryption and address whitelisting, the portal enhances jurisdictions' ability to manage infringement notices and penalties securely and efficiently.

## Expanded capabilities and increased maturity level with IT systems and data services.

The maturity uplift of the Company's IT systems and data services continues. Austroads manages a complex data ecosystem generated from digital data exchanges that facilitate information sharing between different government entities, data-enabled research programs that create key insights into roads and transit, and initiatives that offer training and educational resources to improve transport management and safety. To address the challenges and complexities associated with this fragmented data, Austroads has developed a strategy to adopt a modernised data platform based on the Databricks technology platform. The project is currently well progressed and on track for completion by the end of 2025.

A project to modernise the Telematics Analytics Platform (TAP) was completed during the year which reduced data latency from eight weeks to just hours, giving road managers access to last week's data rather than last month's. The platform user interface was refreshed and load performance improved. Rigorous stress testing was undertaken to support a substantial increase in monitored vehicles.

## Growth and diversification of external revenue streams.

In 2024 Austroads operationalised its implementation of the National Training Framework for Temporary Traffic Management and, as anticipated, this revenue stream has significantly grown this year. Other implementation projects, including the digital drivers licence and the national heavy vehicle driver competency framework projects, are both expected to produce new and diversified revenue streams.

We develop our staff, have positive engagement, and are considered an employer of choice.

In 2025, Austroads was honoured to receive the 5-Star Employer of Choice award from Human Resources Director (HRD) Magazine, recognising outstanding workplace culture, employee engagement, leadership, and professional development across Australia and New Zealand.

## Member's guarantee

The Company is limited by guarantee and is incorporated under the Corporations Act 2001. If the Company is wound up, the constitution states that each member is required to contribute a maximum of \$10 each towards meeting any outstanding obligations of the Company. At 30 June 2025, the total amount that members of the Company are liable to contribute if the Company is wound up is \$110 (2024: \$110).

## Notes to the financial statements

The financial report covers Austroads Limited ('the Company') as an individual entity. Austroads Limited is a public entity limited by guarantee, incorporated and domiciled in Australia.

The functional and presentation currency of Austroads Limited is Australian dollars.

The financial report was authorised for issue by the Directors on 28 October 2025.

Some immaterial reclassifications have been made to the prior year balances in the Statement of Financial Position to be consistent with current year classifications. All other comparatives are consistent with prior year.

## Note 1: Basis of Preparation

The directors have prepared the financial statements on the basis that the Company is a non-reporting entity because there are no users who are dependent on general purpose financial statements. These financial statements are therefore special purpose financial statements that have been prepared in order to meet the requirements of the Corporations Act 2001. Consolidation financial statements, including the results and operations of Austroads subsidiary, Transport Certification Australia, have not been prepared as the directors have determined that the group is not a reporting entity.

These financial statements have been prepared in accordance with the recognition and measurement requirements specified by the Australian Accounting Standards and Interpretations issued by the Australian Accounting Standards Board (AASB) and the disclosure requirements of Presentation of Financial Statements (AASB 101), Statement of Cash Flows (AASB 107), Accounting Policies, Changes in Accounting Estimates and Errors (AASB 108), Interpretation of Standards (AASB 1048), Application of Tiers of Australian Accounting Standards (AASB 1053) and Australian Additional Disclosures (AASB 1054), as appropriate for not-for-profit entities. The principal accounting policies adopted in the preparation of the financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

The financial statements, except for the cash flow information, have been prepared on an accruals basis and are based on historical costs unless otherwise stated in the notes.

The financial statements were approved by the directors of the Company as at the date of the directors' report.

## Note 2: Material Accounting Policy Information

The material accounting policies applied in the preparation of the financial report, which are consistent with the previous period unless otherwise stated, are as follows:

#### (a) Current and non-current classification

Assets and liabilities are presented in the statement of financial position based on current and non-current classification.

An asset is classified as current when it is either expected to be realised or intended to be sold or consumed in the Company's normal operating cycle; it is held primarily for the purpose of trading; it is expected to be realised within 12 months after the reporting period; or the asset is cash or cash equivalent unless restricted from being exchanged or used to settle a liability for at least 12 months after the reporting period. All other assets are classified as non-current.

A liability is classified as current when it is either expected to be settled in the Company's normal operating cycle; it is held primarily for the purpose of trading; it is due to be settled within 12 months after the reporting period; or there is no right at the end of the reporting period to defer the settlement of the liability for at least 12 months after the reporting period. All other liabilities are classified as non-current.

## (b) Revenue recognition

Revenue from contracts with customers
Revenue is recognised at an amount that
reflects the consideration to which the
company is expected to be entitled in
exchange for transferring goods or services
to a customer. For each contract with
a customer, the Company identifies the
contract with a customer; identifies the

performance obligations in the contract; determines the transaction price which takes into account estimates of variable consideration and the time value of money; allocates the transaction price to the separate performance obligations on the basis of the relative stand-alone selling price of each distinct good or service to be delivered; and recognises revenue when or as each performance obligation is satisfied in a manner that depicts the transfer to the customer of the goods or services promised.

Variable consideration within the transaction price, if any, reflects concessions provided to the customer such as discounts, rebates and refunds. any potential bonuses receivable from the customer and any other contingent events. Such estimates are determined using either the 'expected value' or 'most likely amount' method. The measurement of variable consideration is subject to a constraining principle whereby revenue will only be recognised to the extent that it is highly probable that a significant reversal in the amount of cumulative revenue recognised will not occur. The measurement constraint continues until the uncertainty associated with the variable consideration is subsequently resolved. Amounts received that are subject to the constraining principle are recognised as a refund liability.

## Fees and charges

Fees and charges are recognised over the period to which the provision of services relate.

## Contribution revenue

Contribution revenue is recognised at a point in time when received or when the right to receive payment is established.

## Grant revenue

Grant funding that contain specific conditions on the use of those funds are recognised as and when the Company satisfies its performance obligations. A contract liability is recognised for unspent grant funds for which a refund obligation exists in relation to the funding period. General grants that do not impose specific performance obligations on the Company are recognised as income when the Company obtains control of those funds, which is usually on receipt.

#### Interest income

Interest income is recognised on an accruals basis using the effective interest.

#### Other revenue

Other revenue are recognised as income upon receipt of that income.

## (c) Income tax

The Company is exempt from income tax under Division 50-5 of the Income Tax Assessment Act 1997.

## (d) Leases

A right-of-use asset is recognised at the commencement date of a lease. The right-of-use asset is measured at cost, which comprises the initial amount of the lease liability, adjusted for, as applicable, any lease payments made at or before the commencement date net of any lease incentives received, any initial direct costs incurred, and, except where included in the cost of inventories, an estimate of costs expected to be incurred for dismantling and removing the underlying asset, and restoring the site or asset.

Right-of-use assets are depreciated on a straight-line basis over the unexpired period of the lease or the estimated useful life of the asset, whichever is the shorter. Where the Company expects to obtain ownership of the leased asset at the end of the lease term, the depreciation is over its estimated useful life. Right-of use assets are subject to impairment or adjusted for any remeasurement of lease liabilities.

A lease liability is recognised at the commencement date of a lease. The lease liability is initially recognised at the present value of the lease payments to be made over the term of the lease, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, the Company's incremental borrowing rate. Lease payments comprise of fixed payments less any lease incentives receivable, variable lease payments that depend on an index or a rate, amounts expected to be paid under residual value guarantees, exercise price of a purchase option when the exercise of the option is reasonably certain to occur, and any anticipated termination penalties. The variable lease payments that do not depend on an index or a rate are expensed in the period in which they are incurred.

Lease liabilities are measured at amortised cost using the effective interest method. The carrying amounts are remeasured if there is a change in the following: future lease payments arising from a change in an index or a rate used; residual guarantee; lease term; certainty of a purchase option and termination penalties. When a lease liability is remeasured, an adjustment is made to the corresponding right-of use asset, or to profit or loss if the carrying amount of the right-of-use asset is fully written down.

#### Exceptions to lease accounting

The Company has elected to apply the exceptions to lease accounting for both short-term leases (i.e. leases with a term of less than or equal to 12 months) and leases of low-value assets. The Company recognises the payments associated with these leases as an expense on a straight-line basis over the lease term.

## (e) Plant and equipment

Plant and equipment are measured on the cost basis less depreciation and impairment losses.

The carrying amount of plant and equipment is reviewed annually by directors to ensure it is not in excess of the recoverable amount from these assets. The recoverable amount is assessed on the basis of the expected net cash flows that will be received from the assets employment and subsequent disposal.

## Depreciation

The depreciable amount of all fixed assets is depreciated on a straight line basis over the asset's useful life to the entity commencing from the time the asset is held ready for use.

The depreciation rates used for each class of depreciable asset are shown below:

Fixed asset class	Useful life
Furniture and office equipment	3-10 years

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains or losses are included in the statement of profit or loss and other comprehensive income.

## (f) Cash and cash equivalents

Cash and cash equivalents include cash on hand, deposits held at call with financial institutions, and other short term highly liquid investments with original maturities of three months or less.

## (g) Trade receivables

All trade debtors are recognised at the amounts receivable as they are due for settlement no more than 120 days from the date of recognition, and no more than 30 days for other debtors.

There is no provision for expected credit loss allowance, as all receivables are fully recoverable.

## (h) Goods and services tax (GST)

Revenue, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of expense.

Receivables and payable are stated inclusive of GST.

Cash flows in the statement of cash flows are included on a gross basis and the GST component of cash flows arising from investing and financing activities which is recoverable from, or payable to, the taxation authority is classified as operating cash flows.

#### (i) Employee benefits

Provisions for long service leave and annual leave are made for all employees from the date of their commencement and are calculated at current pay rates. Additionally, provision is made for on-costs of 14% on long service leave and annual leave.

Provisions for long service leave for service under ten years is treated as a non-current liability.

#### (j) Trade and other payables

These amounts represent liabilities for goods and services provided to the Company prior to the end of financial year which are unpaid. The amounts are unsecured and are usually paid within 30 days of recognition.

## (k) Intangible assets

Intangible assets acquired separately are recorded at cost less accumulated amortisation and impairment. Amortisation is charged on a straight-line basis over their estimated useful lives. The estimated useful life and amortisation method is reviewed at the end of each annual reporting period, with any changes in these accounting estimates being accounted for on a prospective basis.

#### Research and development

Expenditure during the research phase of a project is recognised as an expense when incurred. Development costs are capitalised only when technical feasibility studies identify that the project will deliver future economic benefits and these benefits can be measured reliably.

The expenditure capitalised includes the cost of materials, direct labour and overhead costs that are directly attributable to preparing the asset for its intended use. Other development expenditure is recognised in profit or loss as incurred.

These assets are not amortised until they are available for use, at which point they are transferred to the relevant intangible asset class and amortised over their estimated useful lives.

## Software

Significant costs associated with software are deferred and amortised on a straight-line basis over the period of their expected benefit being their finite life of five years.

## (I) NEVDIS Reserve

A separate NEVDIS reserve is being shown to highlight profit and loss from NEVDIS activities and historical NEVDIS reserves brought forward. This reserve is separate to the other activities of Austroads.

#### (m) Financial instruments

#### Financial assets

Financial assets are initially measured at fair value. Transactions costs are included as part of the initial measurement, except for financial assets at fair value through profit or loss. Such assets are subsequently measured at either amortised cost or fair value depending on their classification. Classification is determined based on both the business model within which such assets are held and the contractual cash flow characteristics of the financial asset unless an accounting mismatch is being avoided.

Financial assets are derecognised when the rights to receive cash flows have expired or have been transferred and the Company has transferred substantially all the risk and rewards of ownership. When there is not reasonable expectation of recovering part or all of a financial asset, its carrying value is written off.

#### Classification

On initial recognition, the Company classifies its financial assets into the following categories, those measured at:

## · amortised cost

Financial assets are not reclassified subsequent to their initial recognition unless the Company changes its business model for managing financial assets.

#### Amortised cost

The Company's financial assets measured at amortised cost comprise trade and other receivables and cash and cash equivalents in the statement of financial position.

Subsequent to initial recognition, these assets are carried at amortised cost using the effective interest rate method less provision for impairment.

Interest income, foreign exchange gains or losses and impairment are recognised in profit or loss. Gain or loss on derecognition is recognised in profit or loss.

## Impairment of financial assets

The Company recognises a loss allowance for expected credit losses on financial assets which are either measured at amortised cost or fair value through other comprehensive income. The measurement of the loss allowance depends upon the Company's assessment at the end of each reporting period as to whether the financial instrument's credit risk has increased significantly since initial recognition, based on reasonable and supportable information that is available, without undue cost or effort to obtain. Where there has not been a significant increase in exposure to credit risk since initial recognition, a 12-month expected credit loss allowance is estimated. This represents a portion of the asset's lifetime expected credit losses that is attributable to a default event that is possible within the next 12 months. Where a financial asset has become credit impaired or where it is determined that credit risk has increased significantly, the loss allowance is based on the asset's lifetime expected credit losses. The amount of expected credit loss recognised is measured on the basis of the probability weighted present value of anticipated cash shortfalls over the life of the instrument discounted at the original effective interest rate.

## **Financial liabilities**

The Company measures all financial liabilities initially at fair value less transaction costs, subsequently financial liabilities are measured at amortised cost using the effective interest rate method.

The financial liabilities of the Company comprise trade payables and lease liabilities.

## (n) Impairment of assets

At the end of each reporting period, the company reviews the carrying amounts of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair amount less costs to sell and value in use, is compared to the asset's carrying amount. Any excess of the asset's carrying amount over its recoverable amount is recognised immediately in profit or loss.

Where the future economic benefits of the asset are not primarily dependent upon on the asset's ability to generate net cash inflows and when the entity would, if deprived of the asset, replace its remaining future economic benefits, value in use is determined as the depreciated replacement cost of an asset.

Where it is not possible to estimate the recoverable amount of a class of asset, the entity estimates the recoverable amount of the cash generating unit to which the asset belongs.

Where an impairment loss on a revalued asset is identified this is debited against the revaluation surplus in respect of the same class of asset to the extent that the impairment loss does not exceed the amount in the revaluation surplus for that same class of asset.

## (o) Adoption of new and revised accounting standards

There are no new or amended Accounting Standards and Interpretations issued by the Australian Accounting Standards Board (AASB) that are mandatory to the Company for the current reporting period.

Any new or amended Accounting Standards or Interpretations that are not mandatory have not been early adopted. The material accounting policies applied in the preparation of the financial report, which are consistent with the previous period unless otherwise stated, are as follows:

# Note 3: Critical Accounting Estimates and Judgments

The directors make estimates and judgements during the preparation of these financial statements regarding assumptions about current and future events affecting transactions and balances.

These estimates and judgements are based on the best information available at the time of preparing the financial statements, however as additional information is known then the actual results may differ from the estimates.

The significant estimates and judgements made have been described below.

## Key estimates – estimation of useful lives of assets

The Company determines the estimated useful lives and related depreciation and amortisation charges for its plant and equipment and finite life intangible assets. The useful lives could change significantly as a result of technical innovations or some other event. The depreciation and amortisation charge will increase where the useful lives are less than previously estimated lives, or technically obsolete or non strategic assets that have been abandoned or sold will be written off for written down.

## Key estimates - incremental borrowing rate

Where the interest rate implicit in a lease cannot be readily determined, an incremental borrowing rate is estimated to discount future lease payments to measure the present value of the lease liability at the lease commencement date. Such a rate is based on what the company estimates it would have to pay a third party to borrow the funds necessary to obtain an asset of a similar value to the right of use asset, with similar terms, security and economic environment.

## Key estimates - lease term

The lease term is a significant component in the measurement of both the right of use asset and lease liability. Judgement is exercised in determining whether there is reasonable certainty that an option to extend the lease or purchase the underlying asset will be exercised, or an option to terminate the lease will not be exercised, when ascertaining the periods to be included in the lease term. In determining the lease term, all facts and circumstances that create an economical incentive to exercise an extension option, or not to exercise a termination option, are considered at the lease commencement date. Factors considered may include the importance of the asset to the company's operations; comparison of terms and conditions to prevailing market rates; incurrence of significant penalties; existence of significant leasehold improvements; and the costs and disruption to replace the asset. The Company reassesses whether it is reasonably certain to exercise an extension option, or not exercise a termination option, if there is a significant event or significant change in circumstances.

## Key estimates – Provision for expected credit loss

Except as disclosed in the financial statements, the directors have assessed each debtor and believe that the full amount of debtors is recoverable.

# Key estimates – Impairment of non financial assets other than goodwill and other indefinite life intangible assets

The Company assesses impairment of non financial assets other than goodwill and other indefinite life intangible assets at each reporting date by evaluating conditions specific to the Company and to the particular asset that may lead to impairment. If an impairment trigger exists, the recoverable amount of the asset is determined. This involves fair value less costs of disposal or value in use calculations, which incorporate a number of key estimates and assumptions.

## Principal activities

The Company is a national organisation that provides assurance services relating to transport technologies and data to enable improved public purpose outcomes from road transport. Priority outcome areas enabled by the Company's services include improved road safety, transport efficiency, freight productivity, asset management and sustainability.

The Company provides the following broad categories of service, providing opportunities to realise positive outcomes through the deployment of telematics and related intelligent technologies:

- Assurance provides certification of telematics applications, schemes and associated services and data; develops functional and technical specifications for applications and features of the National Telematics Framework; accredits service providers and technology suppliers; type approves devices and systems; and audits service providers technology suppliers, applications, schemes and associated data.
- Administration administers the National Telematics Framework, including the rules, specifications agreements and digital infrastructure that it comprises.
- Analysis and reporting collects, stores and standardises data for aggregation and analysis to support the compliance, policy planning, investment and operational decision making of key stakeholders.

  The Company manages the Telematics Analytics Platform to support user access to data and reporting services and provide core analysis and reporting capabilities to meet the needs of our key stakeholders.

 Advice – provides authoritative information and trusted advice on transport technologies and data to support policy and regulatory reform, and planning.
 The company has well developed knowledge of emerging vehicle and transport technologies, including telematics, connected and automated driving systems, and innovative mobility services.

The Company interacts with three distinct stakeholder groups in providing services across assurance, administration, advice and analysis and reporting, to deliver improved public outcomes:

- Government authorities that administer policies, regulations and programs using telematics and related technologies.
- Transport operators that use telematics and related intelligent technologies in response to government or regulatory policies and programs.
- Service providers and suppliers that develop and deliver telematics (and data) products and services to regulated industry sectors and transport operators.

No significant changes in the nature of the Company's activity occurred during the financial year.

## Member's guarantee

The Company is incorporated under the Corporations Act 2001 and is a Company limited by guarantee. If the Company is wound up, the Constitution states that each Member is required to contribute a maximum of \$10 each towards meeting any outstanding liabilities of the Company. At 30 June 2025 the number of Members was one (2024: one member).

## Notes to the financial statements

The financial report covers Transport Certification Australia Limited ('the Company') as an individual entity. Transport Certification Australia Limited is a company limited by guarantee, incorporated and domiciled in Australia. The Company is a not for profit entity for the purpose of preparing the financial statements.

The functional and presentation currency of Transport Certification Australia Limited is Australian dollars.

The financial report was authorised for issue by the Directors on 24 October 2025.

Comparatives are consistent with prior years, unless otherwise stated.

## Note 1: Basis of Preparation

The directors have prepared the financial statements on the basis that the Company is a non-reporting entity because there are no users who are dependent on general purpose financial statements. These financial statements are therefore special purpose financial statements that have been prepared in order to meet the requirements of the Corporations Act 2001.

These financial statements have been prepared in accordance with the recognition and measurement requirements specified by the Australian Accounting Standards and Interpretations issued by the Australian Accounting Standards Board (AASB) and the disclosure requirements of Presentation of Financial Statements (AASB 101), Statement of Cash Flows (AASB 107), Accounting Policies, Changes in Accounting Estimates and Errors (AASB 108), Interpretation of Standards (AASB 1048), and Australian Additional Disclosures (AASB 1054), as appropriate for not-for-profit oriented entities.

#### Historical cost convention

The financial report has been prepared under the historical cost convention, as modified by revaluations to fair value for certain classes of assets and liabilities as described in the accounting policies.

## Note 2: Material Accounting Policy Information

The material accounting policies applied in the preparation of the financial statements, which are consistent with the previous period unless otherwise stated, are as follows:

## (a) Revenue recognition

## Revenue from contracts with customers

Revenue is recognised at an amount that reflects the consideration to which the company is expected to be entitled in exchange for transferring goods or services to a customer. For each contract with a customer, the Company identifies the contract with a customer; identifies the performance obligations in the contract; determines the transaction price which takes into account estimates of variable consideration and the time value of money; allocates the transaction price to the separate performance obligations on the basis of the relative stand-alone selling price of each distinct good or service to be delivered; and recognises revenue when or as each performance obligation is satisfied in a manner that depicts the transfer to the customer of the goods or services promised.

Variable consideration within the transaction price, if any, reflects concessions provided to the customer such as discounts, rebates and refunds, any potential bonuses receivable from the customer and any other contingent events. Such estimates are determined using either the 'expected value' or 'most likely amount' method. The measurement of variable consideration is subject to a constraining principle whereby revenue will only be recognised to the extent that

it is highly probable that a significant reversal in the amount of cumulative revenue recognised will not occur. The measurement constraint continues until the uncertainty associated with the variable consideration is subsequently resolved. Amounts received that are subject to the constraining principle are recognised as a refund liability.

#### Fees and charges

Operational fees and other service fees are recognised over the period to which the provision of services relate. Application fees are recognised at a point in time when certifications are issued.

#### Contribution revenue

Contribution revenue is recognised at a point in time when received or when the right to receive payment is established.

#### Grant revenue

Grant funding that contain specific conditions on the use of those funds are recognised as and when the Company satisfies its performance obligations. A contract liability is recognised for unspent grant funds for which a refund obligation exists in relation to the funding period. General grants that do not impose specific performance obligations on the Company are recognised as income when the Company obtains control of those funds, which is usually on receipt.

## Interest income

Interest income is recognised on an accruals basis using the effective interest.

#### Other revenue

Other revenue are recognised as income upon receipt of that income.

## (b) Income tax

The Company is exempt from income tax under Division 50-5 of the Income Tax Assessment Act 1997.

## (c) Cash and cash equivalents

Cash and cash equivalents include cash on hand and at banks, short term deposits with an original maturity of three months or less held at call with financial linstitutions, and bank overdrafts. Bank overdrafts are shown within borrowings in current liabilities in the statement of financial position.

#### (d) Trade and other receivables

Accounts receivable and other debtors will include any outstanding contributions from participants, and outstanding operational fees from Service Providers at the end of the reporting period.

## (e) Financial instruments

#### Financial assets

Financial assets are initially measured at fair value. Transactions costs are included as part of the initial measurement, except for financial assets at fair value through profit or loss. Such assets are subsequently measured at either amortised cost or fair value depending on their classification. Classification is determined based on both the business model within which such assets are held and the contractual cash flow characteristics of the financial asset unless an accounting mismatch is being avoided.

Financial assets are derecognised when the rights to receive cash flows have expired or have been transferred and the Company has transferred substantially all the risk and rewards of ownership. When there is not reasonable expectation of recovering part or all of a financial asset, its carrying value is written off.

#### Classification

On initial recognition, the Company classifies its financial assets into the following categories, those measured at:

## · amortised cost

Financial assets are not reclassified subsequent to their initial recognition unless the Company changes its business model for managing financial assets.

## Amortised cost

The Company's financial assets measured at amortised cost comprise trade and other receivables and cash and cash equivalents in the statement of financial position.

Subsequent to initial recognition, these assets are carried at amortised cost using the effective interest rate method less provision for impairment.

Interest income, foreign exchange gains or losses and impairment are recognised in profit or loss. Gain or loss on derecognition is recognised in profit or loss.

#### Impairment of financial assets

The Company recognises a loss allowance for expected credit losses on financial assets which are either measured at amortised cost or fair value through other comprehensive income. The measurement of the loss allowance depends upon the Company's assessment at the end of each reporting period as to whether the financial instrument's credit risk has increased significantly since initial recognition, based on reasonable and supportable information that is available, without undue cost or effort to obtain. Where there has not been a significant increase in exposure to credit risk since initial recognition, a 12-month expected credit loss allowance is estimated. This represents a portion of the asset's lifetime expected credit losses that is attributable to a default event that is possible within the next 12 months. Where a financial asset has become credit impaired or where it is determined that credit risk has increased significantly, the loss allowance is based on the asset's lifetime expected credit losses. The amount of expected credit loss recognised is measured on the basis of the probability weighted present value of anticipated cash shortfalls over the life of the instrument discounted at the original effective interest rate.

## **Financial liabilities**

The Company measures all financial liabilities initially at fair value less transaction costs, subsequently financial liabilities are measured at amortised cost using the effective interest rate method.

The financial liabilities of the Company comprise trade payables.

#### (f) Impairment of assets

At the end of each reporting period, the company reviews the carrying amounts of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair amount less costs to sell and value in use, is compared to the asset's carrying amount. Any excess of the asset's carrying amount over its recoverable amount is recognised immediately in profit or loss.

Where the future economic benefits of the asset are not primarily dependent upon on the asset's ability to generate net cash inflows and when the entity would, if deprived of the asset, replace its remaining future economic benefits, value in use is determined as the depreciated replacement cost of an asset.

Where it is not possible to estimate the recoverable amount of a class of asset, the entity estimates the recoverable amount of the cash generating unit to which the asset belongs.

Where an impairment loss on a revalued asset is identified this is debited against the revaluation surplus in respect of the same class of asset to the extent that the impairment loss does not exceed the amount in the revaluation surplus for that same class of asset.

## (g) Plant and equipment

Plant and equipment is carried at cost less, where applicable, any accumulated depreciation and impairment losses. All assets are depreciated over their useful lives to the Company.

The carrying amount of plant and equipment is reviewed annually by directors to ensure it is not in excess of the recoverable amount from these assets. The recoverable amount is assessed on the basis of the expected net cash flows that will be received from the assets employment and subsequent disposal. The expected net cash flows have not been discounted to their present values in determining recoverable amounts.

#### Depreciation

The depreciable amount of all fixed assets is depreciated on a straight line or diminishing value basis over the asset's useful life to the entity commencing from the time the asset is held ready for use. Leasehold improvements are depreciated over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

The estimated useful lives used for each class of depreciable asset are shown below:

Plant and equipment	2.5-20 years
Computers	2-10 years

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains or losses are included in the statement of profit or loss and other comprehensive income.

## (h) Goods and services tax (GST)

Revenue, expenses and purchased assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of expense. Receivables and payable are stated inclusive of GST.

Cash flows are presented in the statement of cash flows on a gross basis and the GST component of cash flows arising from investing and financing activities which is recoverable from, or payable to, the taxation authority is classified as operating cash flows.

## (i) Trade and other payables

Trade and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the company during the reporting period which remain unpaid. The balance is recognised as a current liability with the amount being normally paid within 30 days of recognition of the liability.

#### (j) Provisions

Provisions are recognised when the Company has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured.

The amount recognised as a provision is the best estimate of the expenditure required to settle the present obligation at the end of the reporting period.

## (k) Intangible assets

Intangible assets are accounted for using the cost model. Development costs, primarily relating to computer software, are capitalised when the item meets the definition of an asset and the entity can demonstrate all of the following: the technical feasibility of completing the asset so that it will be available for use or sale; the intention to complete the asset and use it or sell it; the ability to use or sell the asset; how the asset will generate probable future economic benefits; the availability of adequate technical, financial and other resources to complete the development and to use or sell the asset; and the ability to measure reliably the expenditure attributable to the asset during its development. Otherwise, they are recognised in profit or loss as expenses as incurred. Subsequent expenditure is capitalised only when it increases the future economic benefits embodied in the specific asset to which it relates.

#### Amortisation

Amortisation is recognised in profit or loss on a straight-line basis over the estimated useful lives of intangible assets, from the date that they are available for use.

Amortisation methods, useful lives and residual values are reviewed at each reporting date and adjusted if appropriate.

The amortisation rates used for each class of amortisable asset are shown below:

## (I) Adoption of new and revised accounting standards

The Company has adopted all of the new, revised or amended Accounting Standards and Interpretations issued by the Australian Accounting Standards Board ('AASB') that are mandatory for the current reporting period.

Any new or amended Accounting Standards or Interpretations that are not yet mandatory have not been early adopted.

# Note 3: Critical Accounting Estimates and Judgments

The directors make estimates and judgements during the preparation of these financial statements regarding assumptions about current and future events affecting transactions and balances.

These estimates and judgements are based on the best information available at the time of preparing the financial statements, however as additional information is known then the actual results may differ from the estimates.

The significant estimates and judgements made have been described below.

## Key estimates – estimation of useful lives of assets

The Company determines the estimated useful lives and related depreciation and amortisation charges for its plant and equipment and finite life intangible assets. The useful lives could change significantly as a result of technical innovations or some other event. The depreciation and amortisation charge will increase where the useful lives are less than previously estimated lives, or technically obsolete or non strategic assets that have been abandoned or sold will be written off for written down.

# Key estimates – Impairment of non financial assets other than goodwill and other indefinite life intangible assets

The Company assesses impairment of non financial assets other than goodwill and other indefinite life intangible assets at each reporting date by evaluating conditions specific to the Company and to the particular asset that may lead to impairment. If an impairment trigger exists, the recoverable amount of the asset is determined. This involves fair value less costs of disposal or value in use calculations, which incorporate a number of key estimates and assumptions.

## Key judgment – Allowance for expected credit losses

The allowance for expected credit losses assessment requires a degree of estimation and judgement. It is based on the lifetime expected credit loss, grouped based on days overdue, and makes assumptions to allocate an overall expected credit loss rate for each group. These assumptions include recent sales experience and historical collection rates.
